

Privacy Policy

Sandak-Lewin Property Trust PTY Ltd (“us”, “we”, or “our”) is an Organisation that provides management services to community schemes and rental properties as well providing assistance to prospective buyers and sellers of residential and commercial property with a comprehensive range of professional property services (“Service(s”).

This page informs you of the lifecycle of your Personal Information, namely the collection, using of, storing, sharing, maintaining and destroying of your Information when you use our site. It also advises you on how you (as clients) can update or delete your Personal Information.

1. Information collection and use

2. Storage of personal information

3. Log data

When using the site, we may collect certain information automatically, including, but not limited to, the type of device you use, your device’s unique ID, the IP address of your device, your operating system, the type of Internet browser you use and other statistics (“Log Data”).

4. Location information

We may use and store information about your location depending on the permissions you have set on your device. We use this information to provide features of our Service and to improve and customise our services to you. You can enable or disable location services when you use our website at anytime, through your device settings.

5. Cookies

Cookies are files with a small amount of data, which may include an anonymous unique identifier. We use Functional Cookies that remember who you are as a user of our site. We use them to remember any preferences you may have selected on our site, like saving your username, password or settings. Cookies are sent to your browser from a website and transferred to your device. The Cookies are used to collect information in order to improve our services for you.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. The Help feature on most browsers provide information on how to accept cookies, disable cookies or to notify you when receiving a new cookie.

If you do not accept cookies, you may not be able to use some features of our website and we recommend that you leave them turned on.

6. Do Not Track disclosure

We do not support Do Not Track (“DNT”). Do Not Track is a preference you can set in your web browser to inform websites that you do not want to be tracked.

You can enable or disable Do Not Track by visiting the Preferences or Settings page of your web browser.

7. Compliance with Laws

We will disclose your Personal Information where required to do so by law or if we believe that such action is necessary to comply with the law and the reasonable requests of law enforcement or to protect the security or integrity of our Service.

11. Aggregated statistics

We may collect statistics about the behaviour of visitors to our site. We may display this information publicly or provide it to others. However, Sandak-Lewin Property Trust PTY Ltd will not disclose your personally-identifying information.
